Welcome and Introductions

Our Host, Wolf Saar, welcomed the Council once again to the Weber Thompson Offices. Wolf described his new affiliation with the School of Architecture and Construction Management at Washington State University. The School will be pursuing opportunities for research in these fields. A group of interns from this School is also working at Weber Thompson for the summer.

Some suggestions for research projects were offered: deep kitchen design; bathroom design for adult family homes; "aging in place" designs for assisted living facilities; portable licenses for assisted living; how to educate contractors for universal design; connection between architects and contractors.

- Be thinking about important and needed research in the field of Universal Design. We will ask at the next NWUDC meeting for further suggestions.

Margaret Casey also thanked Maria Langlais for staffing the NWUDC during January through May.

In Mike Vowels' absence, Margaret reported that Mike had worked with the Master Builders' Awards program. They have instituted a new category: "universal design". In June, he received the first award in this category.

This is always a worthwhile event.

Dr. Hartje reported on Draft 8. There is one more meeting of the Task Force to finalize this project.

NWUDC Web site Design Review and Update

ALERT: Maria Langlais opened this discussion by reminding us all of the web etiquette necessary when using the listserv e-mails. If you wish to "reply" to just one sender after some message has come via the listserv (NWUDS@talk2.seattle.gov), ALWAYS be sure to double check the "TO" line before Replying. Otherwise, your reply gets sent to the entire list.

Maria Langlais and Jessica Chow showed the opening web page design and presented the general flow of the web site. Comments and discussion ensued. Jessica and Maria are continuing to work with *Illuminage*, the company doing the web design.

We expect the web site to go live sometime next month. The money to cover this initial web design expense is the NWUDC receipts that have been held in reserve for about 2-3 years as a result of leftover resources from our previous *Aging in Place Resource Fairs*. The Council will have to address on-going funding of the web pages.

LEED for Homes and Other Rating Systems

Scott Starr, SMR Architects, presented a variety of useful information, similarities and differences as well as any inclusion of universal design components in various rating scales available. For example, the U S Green Building Council has approved an Innovative Design Request (IDR) in LEED for Homes, Visitability and Universal Design. It is not considered part of the standard LEED for Homes Rating System. Points are counted under the IDR, ID 3 in the LEED for Homes Rating Project Checklist.

Discussion with Scott revealed a lot of interest in promoting universal design within rating scales for single-family homes but also with respect to the State's Evergreen Standards required for multi-family developments.

Karen Brawley identified that she and Patti Southard, both with King County government, could share the County's comparison between the Evergreen Standards and LEED as well as King county's universal design features for new construction.

The City Office on Housing has done something similar, comparing the Evergreen Standards, LEED and the City's SeaGreen document.

Backyard Cottage Discussion

Andrea Petzel, a Planning and Development Specialist from the City of Seattle's Department of Planning and Development (DPD), in the Land Use Codes and Policy Development Division, presented the Mayor's proposed legislation allowing more homeowners the option to build backyard cottages, a.k.a., "detached accessory dwelling units" under certain conditions. The owner must live on the premises and there would be an annual limit of 50 new cottages.

To ensure the cottages fit within the neighborhood, the lot must be at least 4,000 square feet in area, with minimum width and depth requirements. The principal house and backyard cottage combined must not exceed the current 35% lot coverage limit for single family zones. The cottages can be no more than 800 square feet in area, with a height limit of 15 - 23 foot height depending on lot width, and parking is required.

Currently these backyard cottages are only allowed in Southeast Seattle. The proposed City Ordinance can be accessed here:

Andrea indicated that there will be a public hearing for backyard cottages at **5:30 pm on September 15, 2009** in Council Chambers at City Hall. Public comments are welcome and encouraged.

Prior to the hearing, at **9:30 am on August 12th**, there will be a briefing to the Planning, Land Use and Neighborhoods Committee, chaired by Council Member Sally Clark, which will serve to open the discussion on backyard cottages. While there will be no public comment period specific to backyard cottages at the briefing on the 12th, there will be a general public comment period at the beginning the meeting.
